 - Cost or credit for each alternate is the net addition to or deduction from the Contract Sum to 1. incorporate alternate into the Work. No other adjustments are made to the Contract Sum.

PROCEDURES 1.03

- Coordination: Modify or adjust affected adjacent work as necessary to completely integrate work of A. the alternate into Project.
 - Include as part of each alternate, miscellaneous devices, accessory objects, and similar items incidental to or required for a complete installation whether or not indicated as part of alternate.
- B. Notification: Immediately following award of the Contract, notify each party involved, in writing, of the status of each alternate. Indicate if alternates have been accepted, rejected, or deferred for later consideration. Include a complete description of negotiated modifications to alternates.
- C. Execute accepted alternates under the same conditions as other work of the Contract.
- D. Schedule: A Schedule of Alternates is included at the end of this Section. Specification Sections referenced in schedule contain requirements for materials necessary to achieve the work described under each alternate.

1.04 **REQUIREMENTS**

- Each Prime Contractor is responsible for securing and reviewing the related alternate bids for all of the other separate contracts for this project.
- Each Prime Contractor shall understand the extent of work added or deleted from all contracts and B. shall properly coordinate their work to provide a complete and workable system.
